CALL TO ORDER and ROLL CALL:

- A. The BFPC Special Meeting was called to order at 8:08am by Chairman McKee. Commissioner Dryman, Secretary, called the roll & noted for the record that a quorum was present for the meeting. Present in the Chief's Conference Room were Commissioners Fishman, Dryman, Berman & Chairman McKee. Also present was Fire Lieutenant Dan Downey.

Oral interviews for the top candidates (double the amount needed by the department) would take place the week after the written test or before the next regularly scheduled BFPC Meeting. As soon as the BFPC has the oral interviews completed, the passing candidates will move on to the background teams. All Commissioners agreed to have this as an open topic of discussion for the Chief's.
