VILLAGE OF BUFFALO GROVE Board of Fire and Police Commissioners Minutes of Special Meeting June 21, 2021

CALL TO ORDER and ROLL CALL:

The meeting was called to order at 6:00 P.M. by Chairman Dibbern. Chairman Dibbern, acting as the secretary, called the roll and noted for the record that a quorum was present for the meeting. Present were Commissioners Fishman, Berman, and Chairperson Dibbern. Also, present was Police Tim Gretz, who was sitting in as an observer for the Police Department.

EXECUTIVE SESSION:

- A. - C. A motion was made by Commissioner Berman, seconded by Commissioner Fishman to approve the Lateral Police Officer Preliminary Register, as noted, dated June 21, 2021. Commissioners Fishman, Berman and Dibbern, voted in favor of the motion. The motion passed.
- D. A motion was made by Commissioner Berman, seconded by Commissioner Fishman to approve the Lateral Police Officer Final Register, as noted, dated June 21, 2021. Commissioners Fishman, Berman and Dibbern, voted in favor of the motion. The motion passed.

A motion was made by Commissioner Fishman, seconded by Commissioner Berman to adjourn the meeting at 6:31 PM. Commissioners Berman, Fishman and Dibbern voted in favor of the motion. The motion passed.
